Enclosed are your credentials. **DO NOT CHANGE THE NUMBERS ON YOUR CREDENTIALS.** If your records don't agree with the voting strength or delegates indicated, call the Secretary/Treasurer's office at 614-488-9920. Duplicate credentials (yellow copy) must be returned to the Secretary/Treasurer by **April 18, 2026, along with payment.** Resolutions must be received by the Secretary/Treasurer forty-five (45) days prior to the conference (**April 3, 2026**). To be entitled to representation at conference, locals shall have per capita tax paid on the full membership in accordance with Article X, Section 5 of the Constitution and By-Laws (April payment).
